

# EXTENDED BLACKOUT PERIOD DETRIMENTAL TO HONG KONG'S POSITION AS INTERNATIONAL FINANCIAL CENTRE

To: Honourable Executives of Financial Services and the Treasury Bureau of the HKSAR, the Hong Kong Securities and Futures Commission and the Hong Kong Exchanges and Clearing Limited ("HKEx")

#### DAMAGE TO VIABILITY AND HEALTH OF HONG KONG MARKET

We are a group comprising listed companies in Hong Kong, directors of such listed companies, participants in the securities markets and professional organizations serving the Hong Kong financial industry, who are concerned with the sustainable and healthy development of Hong Kong as an international financial centre. We write to express our strong objection to an amendment to HKEx's Listing Rules\* announced recently, which extends the "blackout period" on directors' dealings in their companies' securities from within one month before the announcement of results to the financial year/period end until the announcement of the relevant results. As such, directors could be prohibited from dealing for up to 7 calendar months in a year. For companies reporting quarterly results, the blackout period will last for up to 9 calendar months. In light of the current environment where the financial tsunami is eroding the well being of all industries and sectors in Hong Kong, not only will this amendment damage the continued viability and health of the Hong Kong market, it will also undermine the legitimate rights and functions of directors as investors.

#### DETERRENT TO EXISTING AND FUTURE LISTINGS ON THE HONG KONG STOCK EXCHANGE

As in other economies in Asia, ownership and management of companies already listed or seeking a listing in Hong Kong are not completely segregated. Directors are often also owners of substantial or controlling interests in the listed companies. The amendment deprives such directors of their legitimate rights as investors and their legitimate expectations of a level playing field. As a result, companies already listed in Hong Kong might relocate to other markets and those contemplating a listing here might decide to list elsewhere. This will inflict damage on Hong Kong's status as an international financial centre.

#### JEOPARDY TO MARKET LIQUIDITY AND SHAREHOLDER VALUE

Against a backdrop of the worsening financial tsunami, prohibiting directors' dealings for an extended period of time will reduce trading volume further, jeopardizing an important source of market liquidity and stable support for shareholder value in unanticipated crises or events. This creates a window of opportunities for corporate snipers to destroy value for both major and small shareholders.

#### DISCOURAGE INDIVIDUALS FROM BECOMING DIRECTORS OF LISTED COMPANIES

Directors of listed companies expend their time and expertise seeking to maintain and improve return for shareholders. The amendment penalizes them by further restricting their freedom to deal in their companies' shares. It will discourage talented individuals of the right calibre from becoming directors of listed companies.

#### CURRENT INSIDER TRADING RULES ADEQUATE

We believe that the existing insider dealing provisions under the Securities and Futures Ordinance and the protection against unauthorized use of price sensitive information under the relevant rules of HKEx already provide adequate scrutiny and safeguard on directors' dealings. Directors are also required to make full disclosure for their dealings. The Listing Rules have outlined explicitly that HKEx regards it as highly desirable that directors should hold securities in companies. Further manoeuvres to the existing regime in this regard constitute a blatant regulatory overshoot.

#### CONSULTATION PROCESS QUESTIONABLE AND HASTY

In addition, we have strong reservations as to whether the public consultation on such an important amendment has been conducted and concluded properly. There was not adequate communication to listed companies and the public to ensure that they are properly informed of such proposal so as to respond or raise objection if they so wish. There was tremendous objection to the proposal with substantive and well-elaborated arguments, and yet no proper evaluation of the substance of the responses was made. We consider it extremely inappropriate that the HKEx concluded that this amendment of such grave impact should proceed in such haste.

### WE HEREBY URGE HKEX TO WITHHOLD THIS AMENDMENT FOR FURTHER CONSULTATION.
